Tk317 crore of govt loan to build Padma Bridge paid back

Bangladesh Bridge Authority (BBA) yesterday paid back Tk317 crore to the government as the first and second installment of the loan given for the construction of the Padma Bridge."Padma Bridge is not just an infrastructure, but a symbol of pride for Bangladesh," Prime Minister Sheikh Hasina said at the cheque handover event on Wednesday (5 April). The total cost of constructing the bridge with internal financing is Tk30 thousand 193 crore. Out of this, Tk300 crore came from aids. The remaining Tk29 thousand 893 crore 38 lakh has been given as loan by the finance division.

The agreement was signed by the BBA and finance division on 29 August 2019. Under the contract, the bridge department will return this amount in 35 years with one percent interest. Government debt repayment from this, the bridge

will be completed in 2056-57 financial year. According to the schedule, a minimum of Tk826 crores to a maximum of Tk1475 crores should be paid every financial year.

The loan will be repaid in a total of 140 installments over four years and 35 years quarterly. In this case, the interest will be calculated on the loan balance after each installment.Apart from this, if the bridge authorities want, they can also pay the money in advance with interest. However, in case of failure to pay an installment, it has to be paid along with the next installment in arrears. The agreement further states that the finance division will assist in fixing the toll rate as per the proposal of the bridge authority for crossing the bridge, so that they are able to repay the debt. The advised toll rate will increase by 10% every 15 years. Apart from this, the bridge **See page-2**



Inflation close to double-digit

Bangladesh sees inflation soar amid price spikes as official arithmetic put the rate at 9.33 per cent for March—the highest in seven months-worsening consumer woes.

High costs of some food items, especially protein items like chickens, eggs, and beef, spurred up the price indices, sources said.

The figures from the Office for Bangladesh's National Statistical Organisation (NSO) showed inflation as measured by the consumer-price index having hit its highest level in August 2022 of this fiscal year, adding to the huge strain on households, especially those in lower-and limited-income brackets.

Economists and analysts say limited-income groups of people, like garment workers, day labourers, and others, suffer much as they have to pay through their nose with their earnings being eroded by the higher inflation.

Onion prices go up

Prices of onion witnessed a hike as its retail prices soared to Tk 40-55 a kilogram on Tuesday, raising the consumers' woes further.

Seasonal onion, known as 'haali', has already captured the market replacing the 'murikata' or seed onion one kg of such variety was found selling at Tk 40-50 a kg, marking a hike of Tk 5.0-6.0 a kg.Imported Indian onions were retailed at Tk 45-55 a kg on the day, according to city groceries and kitchen markets. Finland joins NATO in historic shift sparked by Russia's war

Finland's blue-and-white Nordic cross flag was hoisted outside NATO headquarters on Tuesday as it became the alliance's 31st member, in a historic realignment of Europe's defences spurred by Russia's war on Ukraine.

NATO leaders will now turn up the pressure on their awkward allies Hungary and Turkey to lift their block on Sweden joining. Helsinki's strategic shift -- which ended decades of military non-alignment -- has doubled the length of the USled alliance's land border with Russia and drew an angry warning of "countermeasures" from the Kremlin.

Finland's foreign minister formally sealed Helsinki's membership by depositing the accession papers before the Finnish flag was raised

between those of France and Estonia to the singing of a choir outside NATO's gleaming Brussels headquarters. "Finland now has the

strongest friends and allies in the world," NATO chief Jens Stoltenberg said.

Russian President Vladimir Putin, he said, had "wanted to slam NATO's door shut. Today we show the world that he failed, that aggression and intimidation do not work".

Joining NATO puts Finland under the alliance's Article Five, the collective defence pledge that an attack on one member "shall be considered an attack against them all".

The overall inflation based on the consumer-price index or CPI measured in Laspeyer's formula was 8.78 in February, 8.57 in January, 8.71 in December, 8.85 per cent in November, 8.91 per cent in October, 9.1 per cent in September, 9.52 per cent in August, and 7.48 percent in July.

The BBS, which computes the CPI and then inflation, uses its urban consumer basket for a total of 422 commodities food and nonfood. It includes a rural basket consisting of 318 food and non-food items.



German defence minister quits as pressure grows for Ukraine aid

German Defence Minister Christine Lambrecht resigned on Monday after coming in for months of heavy criticism over Berlin's stuttering response to the war in Ukraine.

Her decision came just days ahead of a crucial meeting of defence ministers from Ukraine's allies, and as Berlin was under intense pressure to provide battle tanks to Kyiv.

A spokeswoman for Chancellor Olaf Scholz said on Monday he would announce a replacement for Lambrecht "in the near future" but government sources told AFP that no decision was expected on Monday on her successor.Lambrecht, 57, said in a statement she had asked Scholz to relieve her of her duties.

"The months-long media focus on my person hardly allows for objective reporting and discussion about servicemen and women... and securi-

Russia produces first nuclear warheads for Poseidon super torpedo

Russia has produced the first nuclear warheads for the Poseidon super torpedoes to be deployed on the Belgorod nuclear submarine, TASS reported on Monday, citing an unidentified defence source.

"The first Poseidon ammunition loads have been manufactured, and the Belgorod submarine will receive them in the near future," TASS quoted the source as saying.

President Vladimir Putin first announced what would become known as Poseidon in 2018, saying it was a fundamentally new type of strategic nuclear weapon with its own nuclear power

In the 2018 speech, Putin said the range of the torpedo would be unlimited and that it could operate at extreme depths at a speed many times that of any submarine or other torpedoes.

"They are very low noise, have high maneuverability and are practically indestructible for the enemy. There is no weapon that can counter them in the world today," Putin said.
